Retired Lanarkshire Dentist Awarded MBE



David Collington MBE

Former NHS Lanarkshire general dental practitioner David Collington has been awarded an MBE. His name was announced in the New Year Honours list 2012.

David, who retired from the North Road Dental Practice in Bellshill in May 2011, was given the award for services to dentistry after 37 years commitment to the NHS. The Strathaven man's NHS dental career began after he qualified from the Glasgow Dental School in 1974. He spent some time as a partner in a practice in Coatbridge before moving to Bellshill where he spent the rest of his career.

David admitted to being very grateful although extremely surprised by the MBE news. He said: "I was genuinely stunned when I heard this but I'm really flattered that someone took the time to consider me for this honour."

He continued: "When I collect it, I like to think I'll be accepting it on behalf of my family and all the dedicated practice staff and colleagues with whom I worked over the years.


"I thoroughly enjoyed my time as a dentist and it's them, along with my loyal patients, who I miss most in my retirement.

Dental Health of Lanarkshire P7 Children Continues to Improve

The National Dental Inspection results for school year 2010/2011 show that the dental health of P7 children in Lanarkshire has improved significantly. The percentage of children in this age group with no obvious decay experience in permanent teeth was 64.2%. This 7% increase from the last P7 result two years ago continues the steady, year on year improvement in the dental health of Lanarkshire's children.

These encouraging results are due not only to the hard work of all the dental teams and oral health promotion teams throughout Lanarkshire but also to the support and input from our colleagues in Education.

Where are you from?

New Edition of Drug Prescribing for Dentistry

Evaluation of HMP Shotts' Oral Health Improvement Programme

An Action Plan for Improving Oral Health and Modernising NHS Dental Services in Scotland identified improving prisoner oral health as a priority for NHS Boards. Prisoners experience more decayed but fewer filled teeth than the general Scottish population. Severe tooth decay is also four times more likely in the male prison population.

NHS Lanarkshire and HMP Shotts developed a three-year oral health improvement programme that started in 2008. It was designed to improve the oral health of staff, prisoners and families of prisoners by creating a healthier environment within the HMP Shotts prison, impacting on policies to promote health as well as providing oral health education.

An evaluation was carried out in 2011 which found that prisoners in the intervention group showed better knowledge of oral health messages. It specifically found that providing health education activities during father-child visits was an effective way of improving knowledge and engaging with prisoners and their families.

The evaluation showed little impact on oral health behaviours including diet and oral hygiene. Only qualitative data from prisoners and prison staff indicated some individual behaviour change. The evaluation also sought to find out what worked well within the project, what difficulties it faced and identify what could be done in the future to overcome these.

The evaluation will help shape the development of future programmes in oral health and health improvement in partnership with HMP Shotts following the transfer of prisoner healthcare to NHS Scotland.

From 1 October 2011 the Index of Orthodontic Treatment Need (IOTN) has been introduced into the Statement of Dental Remuneration. The table below details the relevant pathway in Lanarkshire based on IOTN. Further details are available from

IOTN	PATHWAY
1-3.5	No NHS treatment available*
3.6 – 5	Specialist orthodontist
4-5	Consultant clinic#

*There will be exceptions to this but only in extraordinary circumstances.

#Adult patients – will only be seen if they have complex malocclusions requiring hospital based multi-disciplinary care.

When referring patients, dentists should ensure patients are aware of these arrangements. It would also be helpful if it is clear that the referral is for an opinion on the need for treatment and not for treatment itself.

Radiation inspections for Scotland

A small number of ionising radiation IR(ME)R inspections of dental practices are due to take place in Scotland during the months of April and May 2012. It is hoped that the outcome of these inspections will provide sufficient reassurance to allow IR(ME)R compliance, in future, to be assessed as part of the existing routine dental practice inspection process.
