The Team is made up of a number of different specialities including:

With access to other specialities such as:

Some patients referred to our service will be allocated to a **Community Psychiatric Nurse (CPN)**.

Your CPN is your **Named Nurse** and will coordinate all your care within the service.

WHAT WE DO

We provide specialist advice and treatment for adults over the age of 65 with mental health problems throughout the Clydesdale area. We might also support patients aged between 60-64 years, based on a holistic assessment of needs.

Each person will have a full assessment looking at all their care needs.

We offer a wide range of treatment options on a 1:1 basis either at home or in our out patient facility.

Our treatment options include:

- ❖ Anxiety & Depression management
- ❖ Medication management
- ❖ Post Diagnostic Counselling for Dementia, Carer education and support
- ❖ Occupational Therapy assessment
- ❖ Psychiatric Outpatients Clinic
- ❖ Psychological assessment

SPECIAL AIDS

If you require any special arrangements for example an interpreter, someone to sign if you are deaf, assistance if you are visually impaired, please contact the department as soon as possible. For those attending our outpatient clinics or groups, the health centre has wheelchair access and lift facilities. Guide and hearing dogs are permitted.

SMOKING

In compliance with the provisions of the "Smoking, Health and Social care" (Scotland) Regulations 2006, you are not permitted to smoke within any of NHS Lanarkshire's grounds. In the interest of staff safety we would also request you refrain from smoking during any home visits.
