

ELIGIBILITY

The Bellshill community mental health team for older adult provide assessment, intervention and support to people aged 65 and over who are experiencing a decline in their mental health, including dementia. Our team cover Bellshill/Viewpark locality.

HOW YOU ACCESS THE SERVICE

The Community Mental Health Team accept referrals from Health Professionals.

WHEN IS THE SERVICE AVAILABLE

Monday to Thursday 8.55am - 5pm. Friday 8.55am - 4.30pm. The service is closed on public holidays.

Out with normal working hours you can contact: NHS 24 on 111.

WAITING LISTS

On receipt of referral you will be placed on our waiting list.

This is normally 6 weeks or less. You will be contacted by a member of the team to arrange an appointment.

ELIGIBILITY

If you require any special arrangements for example an interpreter, someone to sign if you are deaf, assistance if you are visually impaired, please contact the department as soon as possible. For those attending our outpatient clinics or groups, the health centre has wheelchair access and lift facilities. Guide and hearing dogs are permitted.

SMOKING

Smoking or use of electronic cigarettes is not permitted in and on NHS Lanarkshire's buildings and grounds.

Smoking indoors causes harmful chemicals to linger up to 5 hours, therefore please do not let anyone smoke at least an hour before we visit.

It is never too late to stop smoking, and the best way to do it is with support from the Nurse Specialist of your local Stop Smoking Service.
